Consolidated Carpet Modernizes Offices with FreeAxez Flooring Solutions

Consolidated Carpet (Consolidated) was recently retained to resolve office flooring challenges utilizing FreeAxez' Low Profile Access Floor at the New York City Office of the Public Administrator and at Johnson & Johnson's World Headquarters in New Brunswick, NJ.

FreeAxez provides unparalleled capacity and flexibility for the high technology environment, saving life cycle costs and improving workplace efficiency. FreeAxez is the most cost effective patented all steel, quick connect raised access flooring system available that allows for ease of installation and adapts to any space. FreeAxez is approved for non plenum-rated cable, promotes building re-use and preservation and is recyclable and reusable.

Updating a Landmark

Occupying space in the Surrogate Courthouse at 31 Chambers Street, the New York City Office of the Public Administrator is housed in a Landmark Beaux Arts-style building built between 1899 and 1911. The challenge was to find a solution that would allow for flexible placement of electrical/data ports, eliminate the need for costly and damaging core drilling and address the challenge of navigating Landmark-designated double wooden doors which swung into the workplace.

Consolidated created an entry ramp to the room to allow for the raised flooring while maintaining the Landmark-designated doors. The installation of 4,500 square feet of flooring took place without interrupting daily office operations, providing for all of the client's requirements. Consolidated then covered the FreeAxez floor with Bigelow's "Doctor" quality carpet tile.

A New Meeting Center

Johnson & Johnson contracted Consolidated to utilize FreeAxez' Low Profile Access Floor in the construction of a new executive conference and meeting center. The 14,000-square-foot, heavily-wired space required the movement of 45 electrical and data floor boxes as part of the advanced technological requirements in the conference center. Consolidated dismantled FreeAxez flooring from another area within Johnson & Johnson's offices, reusing it in the new space. This was the first time Consolidated re-used access flooring for a client,



cutting down on project lead time and cost.
